

RMB Cash Intelligence Index (Total return, ZAR)

Fact sheet for 31 January 2018

Investment strategy and objective

The RMB Cash Intelligence Index tracks the daily performance of a portfolio of money market instruments in South African rand. The index is formed from the weighted average return of investments in overnight, 1-month, 3-month, 6-month, 9-month and 12-month maturity deposits calculated from the official benchmark fixing rates. The index is fully investable and provides a total return.

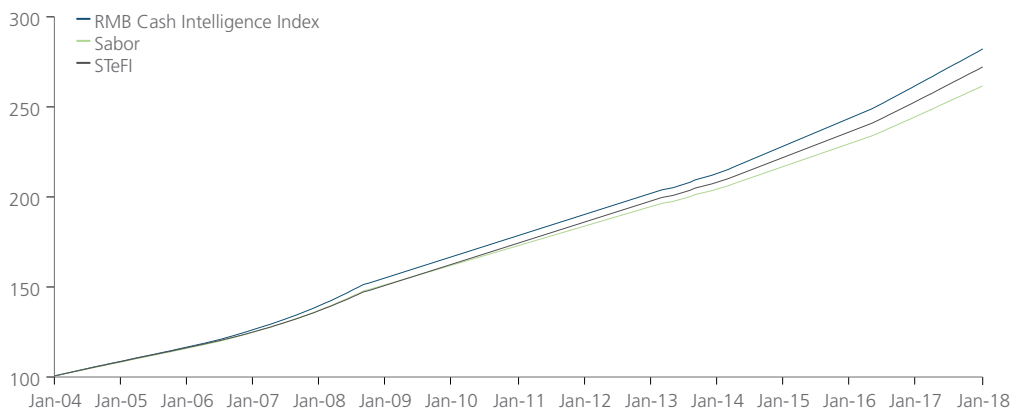
